In order to ensure that the residents of the Town of Brewster gain the maximum benefit from their Town owned facility, it is the intention of the Town of Brewster that only those who meet, and can document that they meet, the standards established by the Brewster Golf Commission, qualify for Annual Fee Player status.

INSTRUCTIONS:

1. A separate application is required for each individual applying for Annual Fee Player status.
2. Payment in full must accompany each application. The annual fees are as follows:
 - a. Brewster Resident \$ 700.00 (categories #1, #2, #3, & #4)
 - b. Junior \$ 175.00 (category #5)

Please make checks payable to Town of Brewster. If mailing, please mark “**Attention AFP**” on outside of envelope.

3. All applications received by March 25, 2010 will be processed by April 1, 2010, which is when the current Annual Fee Passes expire. Any application received after March 25, 2010 will require five (5) business days to process. An application is not considered to be submitted until all the required documentation is received and approved.

DOCUMENTATION: (the Captains will be happy to make copies of the required documentation for you.)

The following documentation must accompany each application:

1. **Category #1 - Full -Time Brewster Resident Taxpayer and Domiciliary:**
 - a. *For new AFP applications only*, a copy of a valid Massachusetts Driver’s License reflecting your property address as the same address listed on the Real Estate Property Owner List from the Brewster Assessor’s office; and
 - b. The validity of your Brewster residency will be verified with the Real Estate Property Owner List from the Brewster Assessor’s office. If you are not included on this list, you will be required to submit either a copy of your deed or current real estate tax bill.
2. **Category #2 - Part Time Brewster Resident Taxpayer:**
 - a. *For new AFP applications only*, a copy of a valid driver’s license; and
 - b. The validity of your Brewster residency will be verified with the Real Estate Property Owner List from the Brewster Assessor’s office. If you are not listed on this list, you will be required to submit either a copy of your deed or current real estate tax bill. In addition, if any individual, other than your spouse or dependent child, is registered in the Town Clerk’s office as being domiciled at your Brewster property, then you do not qualify for AFP status.
3. **Full-Time Brewster Resident Non-Real Estate Tax Payer and Domiciliary – Category #3**
 - a. *For new AFP applications only*, a copy of a valid Massachusetts Driver’s License reflecting your Town of Brewster residence address; and
 - b. A copy of a signed lease reflecting your Brewster residence address that indicates that you have lived in this Brewster residence for at least six (6) months prior to this application, or a notarized original written statement, signed and sworn under the pains and penalties of perjury, by both you and the owner of a Brewster property indicating that you have been residing full-time in their residential dwelling for at least the past six (6) months.
4. **Spouse – Category #4**
 - a. *For new AFP applications only*, a copy of a valid driver’s license.
 - b. *For new AFP applications only*, if your last name is different from your spouse’s, or if your address does not match that of your spouse’s, further verification will be required.
5. **Junior – Category #5**

- c. full-time students must provide a current student ID or school transcript verifying status.
