\_\_\_\_\_ *Twilight* - \$468: May play one hour prior to the start of the Twilight green fee rate. This time varies based on the time of year. See our rate sheet for Twilight time starts. **EARLY BACK 9 PLAY IS NOT ALLOWED FOR THIS CATEGORY.**

The following statement must be true in order to qualify for any of the above Brewster Resident AFP categories:

I (or my spouse) am a Brewster real estate taxpayer for property with an annual tax bill of at least \$450, OR I am a full time resident of Brewster, MA domiciled at the address on this application and I have lived there for at least the last six (6) months prior to this application. No more than two (2) individuals, unless that person is your spouse or dependent child, may qualify for AFP status, based on the Brewster residence listed on this application.

\_\_\_\_\_ *Junior* (12 – 18 years) - \$204: Play is restricted to after 3:00 p.m. unless accompanied by an adult player. I am the minor child of a Brewster resident who meets the qualifications above, who will have reached my 12<sup>th</sup> birthday by December 31, 2021 and who will not have reached my 19<sup>th</sup> birthday before April 1, 2021.

\_\_\_\_\_ *Collegiate* (19 – 25 years) - \$407: Play is restricted to after 12:00 noon unless accompanied by an adult player. I am the son/daughter of a Brewster resident who meets the qualifications above, and I am a full-time student who will not have reached my 25<sup>th</sup> birthday before April 1, 2021. Proof of school enrollment required.

In order to ensure that the residents of the Town of Brewster gain the maximum benefit from their Town owned facility, it is the intention of the Town of Brewster that only those who meet, and can document that they meet, the standards established by the Brewster Golf Commission, qualify for Annual Fee Player status.

**INSTRUCTIONS:**

1. A separate application is required for each individual applying for Annual Fee Player status.
2. Payment in full must accompany each application. Please make checks payable to Town of Brewster. If mailing, please mark "**Attention AFP**" on outside of envelope.
3. Credit card payments are accepted **ONLY** via our on-line payment system at [www.captainsgolfcourse.com](http://www.captainsgolfcourse.com). There is a service fee charged for using the on-line feature.
4. All applications received by March 25, 2021 will be processed by April 1, 2021, which is when the current Annual Fee Passes expire. Any application received after March 25, 2021 will require five (5) business days to process. An application is not considered to be submitted until all the required documentation is received and approved.

**DOCUMENTATION:** (the Captains will be happy to make copies of the required documentation for you.)  
The following documentation must accompany each application:

**1. Adult Brewster Taxpayer Categories**

- a. **For new AFP applications only**, a copy of a valid Massachusetts Driver's License reflecting your property address as the same address listed on the Real Estate Property Owner List from the Brewster Assessor's office; and
- b. The validity of your Brewster residency will be verified with the Real Estate Property Owner List from the Brewster Assessor's office. If you are not included on this list, you will be required to submit either a copy of your deed or current real estate tax bill.

**2. Junior Brewster AFP Category**

- a. **For new AFP applications only**, either a copy of your birth certificate, your valid driver's license, or some other form of picture identification that verifies your date of birth; and
- b. a copy of a valid driver's license from one of your parents; and/or
- c. full-time students must provide a current student ID or school transcript verifying status.
