In order to ensure that the residents of the Town of Brewster gain the maximum benefit from their Town owned facility, it is the intention of the Town of Brewster that only those who meet, and can document that they meet, the standards established by the Brewster Golf Commission, qualify for Annual Fee Player status.

INSTRUCTIONS:

- 1. A separate application is required for each individual applying for Annual Fee Player status.
- 2. Payment in full must accompany each application. Please make checks payable to Town of Brewster. If mailing, please mark "Attention AFP" on outside of envelope.
- 3. Credit card payments are accepted ONLY via our on-line payment system at www.captainsgolfcourse.com. There is a service fee charged for using the on-line feature.
- 4. All applications received by March 25, 2025 will be processed by April 1, 2025, which is when the current Annual Fee Passes expire. Any application received after March 25, 2025 will require five (5) business days to process. An application is not considered to be submitted until all the required documentation is received and approved.

DOCUMENTATION: (the Captains will be happy to make copies of the required documentation for you.) The following documentation must accompany each application:

1. Adult Brewster Taxpayer Categories

- a. *For new AFP applications only*, a copy of a valid Massachusetts Driver's License reflecting your property address as the same address listed on the Real Estate Property Owner List from the Brewster Assessor's office; and
- b. The validity of your Brewster residency will be verified with the Real Estate Property Owner List from the Brewster Assessor's office. If you are not included on this list, you will be required to submit either a copy of your deed or current real estate tax bill.

2. Junior Brewster AFP Category

- a. *For new AFP applications only*, either a copy of your birth certificate, your valid driver's license, or some other form of picture identification that verifies your date of birth; and
- b. a copy of a valid driver's license from one of your parents; and/or
- c. full-time students must provide a current student ID or school transcript verifying status.
